An additional security deposit fee of \$250.00 will be collected by credit card at time of rental pickup. This deposit will be refunded when the rental property is returned in the same condition as indicated and agreed upon at time of rental

Hitch and Go Adventures, LLC collects (2) charges for Teardrop rental:

- (1) 50% of the expected rental fees and when you make reservation**
- (2) \$250.00 security deposit.....and remaining balance of rental fee (including 10% total rental tax).....(due on the day of rental pickup.)**

Security Deposit: *The security deposit will be returned to you upon the return of the rental trailer in satisfactory condition, as when received. We may use the deposit to pay any amounts owed to us under this agreement. If the amount of the security deposit is insufficient to satisfy all amounts due then the Renter agrees to pay all charges in excess, either by cash or authorized use of the credit card provided.*

I UNDERSTAND THAT HITCH AND GO ADVENTURES, LLC COLLECTS 50% OF TOTAL RENTAL PRICE WHEN RESERVATION IS MADE (including 10% sales tax of total rental price). BALANCE OF RENTAL FEE IS DUE AT RENTAL PICKUP, AS WELL A REFUNDABLE \$250 SECURITY DEPOSIT. THIS DEPOSIT IS TO BE REFUNDED WHEN THE RENTAL TRAILER IS RETURNED IN THE SAME CONDITION AS WHEN PICKED UP: _____ renter initials

Please review all disclosures below carefully. Your initials indicate your agreement and acceptance to the below disclosures, and outlines your responsibility as the renter. **READ IT CAREFULLY.** Be sure that all spaces are filled before signing below:

DURATION: The rental period shall be equal to the days/nights stated above. Renter must return the Trailer/Equipment to our rental office or other location we specify, on the date and time specified in this Agreement, and in the same condition that you received it, except for ordinary wear. If the Trailer/Equipment is returned after closing hours, Renter remains responsible for the safety of, and any damage to, the Trailer/Equipment until we inspect it upon Company's next opening for business. If the Trailer/Equipment is not returned on the due date specified, a \$100.00 dollar late fee will be charged per day that the Trailer/Equipment is late.

CHARGES: Renter agrees to pay Company for all charges due Company under this Agreement, including but not limited to:

- Time for the period during which Renter keeps the Trailer/Equipment. Charges for optional products or services Renter elects to purchase.
- Loss of, or damage to, the Trailer/Equipment which includes the cost of repair, or the actual cash value of the Trailer/ Equipment based on valuation methods accepted by the insurance industry on the date of the loss if the Trailer/ Equipment is not repairable, or if we elect not to repair the Trailer/Equipment, plus an administrative expense incurred in processing the claim.
- Cleaning Fees.
- Actual expenses we incur in locating and recovering the Trailer/Equipment if Renter fails to return it or Company elects to repossess the Trailer/Equipment under the terms of this Agreement.

RENTAL, INDEMNITY, AND WARRANTIES: This Agreement is a contract for the rental of the Trailer/Equipment. We may repossess the Trailer/Equipment at Renter's expense without notice to Renter, if the Trailer/Equipment is abandoned or used in violation of law or this Agreement. Renter agrees to indemnify Company, defend Company and hold Company harmless from all claims, liability, cost and attorney fees incurred by Company resulting from, or arising out of, this rental and Renter's use of the Trailer/Equipment. We make no warranties, express, implied or apparent regarding the Trailer/Equipment, no warranty of merchantability, and no warranty that the Trailer/Equipment is fit for a particular purpose.

OWNERSHIP AND LIABILITY FOR DAMAGE OR LOSS – Hitch and Go Adventures retains ownership of the property rented to you. In the event the rental property is stolen, lost, damaged or destroyed while in your possession, you, as the renter, will be fully responsible for its repair or replacement at fair market value at the time of such damage or loss. This responsibility applies regardless of whether the property is operated by someone other than the renter without the renter's knowledge or permission.

INSURANCE: You as the renter agree to provide proof of **FULL COVERAGE INSURANCE** on the tow vehicle, and maintain such while the rental property is in your possession. **(Must be at least 25 years old to rent.)** Your coverage **MUST** be able to be verified prior to rental, and a copy of your insurance card will be made for our records. Your vehicle insurance likely extends coverage to rental property while being towed by your vehicle; however, it is strongly recommended that you confirm your coverage prior to rental. No additional insurance is offered or implied and is not included in this rental.

PERSONAL PROPERTY: Renter releases Hitch and Go Adventures from all claims for loss of, or damages to, your personal property or that of any other person, that was left or carried in the Trailer.

CONDITION OF TRAILER: We shall provide the Trailer/Equipment in clean and operating condition. Service to the Trailer/ Equipment or replacement of parts during the rental must have Company's prior approval. Renter must check and maintain all fluid levels and tire air pressure during the rental period.

DRIVER REQUIREMENTS: While the camper is attached.....the Towing Vehicle can only be driven by an authorized driver 25 years of age or older possessing valid and identifiable drivers license. All drivers must be covered under the Renter's insurance and will be bound by the terms and conditions of this rental agreement.

CLEANING FEE: We shall provide the Trailer/Equipment in clean and operating condition. \$50 excess cleaning fee is applicable.

OCCUPANTS: No person shall be in Trailer when it is in motion and being towed.

You understand that the rental trailer and all contents, provided chairs, tables, tents, utensils, dishware, appliances and any additional supplies provided at the time of rental are considered rental property as well and are to be returned in satisfactory condition upon return. The cost to replace such missing goods will be deducted from the security deposit at the end of the rental.
